- **5. Financial Integrity** a. MMIH maintains accurate and transparent financial records, subject to independent audit. b. Donations will be used for the purposes specified by the donor, and any surplus funds will be allocated in accordance with our budget and priorities.
- **6. Amendments** This Donor Policy may be amended from time to time by the Board of Directors of MMIH to reflect changes in our operations, legal requirements, or best practices.
